#### 2. DECLARATIONS OF INTEREST

**3. MINUTES OF MEETING 13**<sup>th</sup> **August 2013** were approved as a true and accurate representation of the meeting. Proposed by AM and seconded by LG-L.

## 4. MATTERS ARISING FROM THE LAST MEETING

a) **Speed Limit** Comment made that the new 30 mph signs in Kilmelford are large and ugly. Advised that they have to be large to be visible. Thanks to be conveyed to the Roads Team at the Council for implementing the new 30 mph limit and the extension of it to embrace the Degnish road junction with A816.

b) **Community Emergency Plan** MA reported that it was no further forward. LG-L and JM to bring a draft of basic plan to next meeting.

c) **Community Council Elections** NM thanked Lucy Files, John MacLean, Matthew Anderson who are resigning and Colin Clark and Stuart Cannon for their support and help. Only one person has put their name forward so as of 31st October there will be no Community Council. A by-election will be held with 18th November close of nominations and election held 19th December. If 8 or less nominees, there will be no need for an election and the new community council could be in place by the next meeting on 10th December.

d) **Accounts** MA to produce up to date accounts.

e) **Glenmore Farm (Forestry Commission Scotland)** Forestry Commission (FC) organised an afternoon on 17th September for the public to express their views. It was very well attended. FC collating comments and producing a scoping plan which will be made available to the community for further comment. Community Council to write to FC outlining the views of those who wish to have a say in what happens to the land.

f) **Musdale Wind Farm** AM, NM and CC had a meeting with two people from Infinis. KKCC will have to comment but unable to do so until SNH has come to a conclusion and Environmental Impact Assessment has been produced. Other community councils are involved. Nothing will happen until about 2020. The condition of the public road is reported to be appalling and "the worst in Scotland" as a result of the development of the Carraig Ghael windfarm.
