- 4. MATTERS ARISING FROM MEETING HELD 9th February 2021: -

# a) Access Issue Kames Bay -

No real progress ER had again reported the problem to the Access Officer. He is dealing with multiple access cases but his Head of Department is aware of the issues. Regarding Shipping Container blocking one of accesses, The Enforcement Officer had reported that he has contacted landowners with no response and their solicitor who advises the matter will be looked in to. He assures tat he will continue to pursue the matter to resolution.

- b) Community Trust Company DW Had approached a solicitor to check out cost and effect of having 2 companies one for Kilninver and one for Kilmelford. He would report back once has a reply.
- c) Covid Box of Kindness RC/LL reported that it is being used, not a lot has gone but a top-up shop has been done, using Covid related funds. More publicity will be done via our social media.
- d) Carraig Gheal Wind Farm Micro Grants DW reported that we have been successful with our 2 applications for a bench and Car Park Tidy (DW thanked GP for doing the applications). We can now push forward on getting the jobs done remembering that the bench will need to be secure to stop it either blowing away or being stolen.

There is a survey online open until 8/5/2021. There is the potential for £750,000 per year so comments wanted.
