2) MINUTES OF THE LAST MEETING

The minutes were approved as a true record.

3) MATTERS ARISING

a) TM has contacted Colin Clark to ask whether the bowling mats stored under the stage are still required.
b) OS reported on the Christmas Fayre. It went very well, making a profit of £1238.71. Toys to the value of £30.00 were left over and will be held by OS and used next year. Santa's Grotto, run by LF, was a particular attraction. TM thanked OS on behalf of the committee for her organisation of the Fayre.
