What with increasing planning applications for housing, including over 190 at Craobh Haven, wind farm applications, shell fish farm applications, debate on the future of the Oban Hospital and the presentation of the draft Argyll and Bute Local Plan, it is inevitable that there will be changes and that there will be a diversity of opinion on each and every issue. One of the main means of getting your opinion heard and of having some impact on the shaping of our community's development is to attend Community Council meetings.

Community Council meetings take place on the second Tuesday of every second month but, more and more additional meetings are having to be called to discuss issues such as planning applications that need to be dealt with before the regular meeting, or to deal with special issues such as the draft Argyll and Bute Local Plan and so on. Inevitably, these meetings sometimes have to be called at relatively short notice and the only means of notifying people, at present, is by way of noticeboards and word of mouth.

We therefore propose to compile a list of e-mail addresses of anyone wishing to receive Community Council information by e-mail. If you would like to be kept up-to-date by this means, please visit www.kilmelford.com and follow the instructions. You will be sent an e-mail with a link that you can click on to subscribe. This system of registration has been devised in order to ensure that the registration is bona fide and also to avoid all registered e-mail addresses being added to everyone's address book which would increase the dangers of you receiving more spam and of the spread of viruses. Those of you who gave your e-mail addresses for registration at the Community Council meeting need not register again.

For those of you without e-mail facilities, rest assured that e-mailing information will be an additional means of communication and will not replace any of the other methods of communication.

LEMON DRIZZLE CAKE (SET RECIPE FOR CLASS 30)

6oz self raising flour, 1½ teaspoons baking powder, 2 medium eggs, 6oz castor sugar, 4oz soft margarine, 4 tablespoons milk, rind of a lemon

- 1. Put all the ingredients **except the lemon rind** into a bowl, mix by hand or mixer until all are well mixed.
- 2. Stir in lemon rind.
- 3. Put into a 7" cake tin that has been well greased and dusted with flour. Bake at 180C or Gas 4 for 30 to 40 minutes until firm to the touch. Leave in tin.

Juice of the lemon, 4oz of sugar

4. Dissolve the 4oz sugar in the lemon juice (this can be done in a microwave) and pour over the HOT cake.

KILNINVER AND KILMELFORD COMMUNITY COUNCIL.

An extra-ordinary meeting of the above Council was held on 21st January 2004 to discuss Planning Application Ref: XX100/165B, by Alan MacDonald for permission to cultivate mussels/ scallops at Loch Melfort (NM 830 125 & NM 818 131). Present were 6 Community Councillors, and 38 members of the public. It was unanimously agreed to object to this application, and that the same reasons would be valid for the application by Celtic Seafoods Ltd.

An ordinary general meeting of the above Council was held on Tuesday 10th February 2004. In attendance were six Community Councillors, Argyll and Bute Councillors Alan Macaskill and Duncan MacIntyre, and 31 members of the public.

The meeting commenced with an update on the ongoing situation between the Community Council and Melfort Pier and Harbour. Since John Christlieb has, in national media, publicly accused the Community Council of acting unlawfully, it was advised that confirmation had been sought from Councillors Macaskill and MacIntyre that they were fully supportive of the secretary and the Community Council in all aspects of this matter. In addition, at the chairman's request, the chairman and secretary had met with Susan Mair, Head of Legal and Protective Services in Argyll and Bute Council, with Councillor Macaskill in attendance, to review all the Community Councils activities since 1997. Susan Mair had concluded that the Community Council had acted properly in all matters, and in accordance with its own standing orders, as well as those of Argyll and Bute Council (with the exception of, and for documented and legitimate reasons, the 2003 AGM had been postponed at the last minute, and rescheduled ten days outwith the time period stipulated in the Community Council standing orders; however, this was deemed to be of no significance). It was noted by Councillor Macaskill that Susan Mair had written to John Christlieb detailing her findings. A subsequent letter in the Oban Times, from Melfort Pier and Harbour, was not considered worthy of comment or reply. Councillor MacIntyre advised that he had written a letter for the Oban Times supporting the secretary and the Community Council. It was agreed that no further action was required until an apology from

Melfort Pier and Harbour was received, and that it was hoped that this matter could be laid to rest.

Other business discussed included: the need to repair the Scammadale road, and that a site meeting would be held shortly with the Roads Department; a community grant was being awarded to install wooden planters at various location in Kilmelford; the access improvement works had been completed at Blaran road end, but there had been no progress on the issue of removing the dangerous telegraph poles; Colin Clark was hopeful of getting a Community Council notice board in place very shortly.

The Celtic Seafood mussel sites application was discussed, and it was agreed that the Community Council should object again. Members of the public were advised to write also. It was noted that the Argyll and Bute Local Plan Consultative Document was now available, with responses requested by 12th March 2003. It was agreed that an open evening would be held on Tuesday 17th February 2003 at Kilmelford Village Hall at 8.00pm, where copies of the plan would be available for public viewing. It was reported that another letter of planning questions most asked at Community Council meetings had been submitted to Angus Gilmour. Cllr Macaskill advised that the intention was to hold a meeting for Community Councillors to allow discussion on planning issues.

ARGYLL AND BUTE LOCAL PLAN CONSULTATION DOCUMENT

After an open evening held on 17th February, where copies of the Draft Local Plan were made available for public inspection, it was agreed that a review of the plan would be conducted by Angus MacFadyen (Kilninver), Neil Manchester and Alasdair Oatts (Kilmelford) and Stuart Cannon (Kames and Arduaine). The findings of these reviews were discussed at a further extra-ordinary public meeting held on 9th March 2004, attended by five Community Councillors and 18 members of the public, where it was agreed that the following representations be submitted to Argyll and Bute Council:

To: Ian Love, Head of Statutory Plans, Argyll and Bute Council

Argyll and Bute Local Plan Consultation Draft

Re your letter dated 23 January 2004 and copy of the above document, I would like to note that we have not been contacted by the Development Policy Unit during the consultative period to clarify the provisions of the plan as stated in your letter.

Since the consultation period ends on 12 March 2004, this Community Council has met twice, with a significant number of members of this community present, to discuss the content of the document and wish to submit the following representations at this stage:

- a) The Kilninver and Kilmelford Community Council consider the six-week consultation period to be wholly inadequate, especially without Argyll and Bute Council support and guidance, to effectively review and consider every aspect of such a wide-ranging and long-term document. As such, we request an additional consultation period of ten weeks, with a detailed and structured input from the document authors.
- b) There appears to be little or no regard to the development of the existing infrastructure in all the areas covered in this plan. The issues of sewage disposal, water provision and electricity supply have to be addressed before any further significant development can be considered. In addition, the Argyll and Bute roads network is barely capable of sustaining current levels of traffic, yet the plan highlights major potential development areas with no regard to traffic issues. In particular, there are current proposals for a major housing development at Craobh Haven which will add to traffic levels significantly, yet the draft plan does not suggest how the extra volume is to be managed. This Community Council requests further information on the future traffic management strategy, and also the long-term implications of the Craobh Haven development.
- c) It has been noticed that there are a number of inaccuracies on some of the maps, and in particular the omission of existing development in 'sensitive areas'- notably the omission of the latest dwelling to

- the rear of Kilmelford Yacht Haven. Since this development was completed in 2001, it should be included on a map dated 2004.
- d) There is a contradiction shown for land on the east side of the A816 in Kilmelford. On map number 5/B/1/23 (page 85) this field is shown as an Area of Search (AOS), while on map number 5/C/1/13 (page 110), at least two thirds is shown as an Open Space Protection Area (to which no definition appears to exist in the glossary supplied). Since this area is used as a sports playing field, we would wish it to remain as a protected area.
- e) While accepting the principle of permitting development within settlement boundaries, concern has been expressed at the number of proposed Potential Development Areas outwith any rational boundaries. PDA 5/129, shown on map 5/B/1/23 (page 85) is significantly outwith the Kilmelford settlement boundary, and in an area of agricultural and scenic value. As such, we do not feel that this area should be zoned in this manner.
- f) PDA 5/128, is shown on map 5/B/1/23 (page 85) as a Sensitive Area. We consider this to be outwith the settlement boundary, and is an area where development has been strongly opposed by the community in the past. As such, this area should not be classified as a PDA.
- g) PDA 5/126 shown on map 5/B/1/23 (page 85) does not show the historic site (cairn) in the centre of this area, and part of this land should be reclassified accordingly to prevent future development. In addition, since this area is immediately adjacent to the Kilmelford Village Hall, this Community Council wishes to register an interest in this ground as potential development of a sports/ recreation area to complement the existing facilities.
- h) Map number 5/B/1/31 on page 93, Loch Melfort, shows PDA 5/141, PDA 5/142 and an Area of Search, which represents a potential significant development in this area. It must be noted that the current level of services, ie water and sewage, are inadequate for the existing development, and the Degnish road is already at saturation point and entirely unsuitable for additional traffic from

further developments. Either the PDA's must be revised, or provision must be included in the plan for the upgrade of the access road and infrastructure to Melfort and Degnish.

- i) The proposed options for a Kilmelford by-pass/ road straightening programme, DRA 5/15 shown on map 5/B/1/23 on page 85, require much further consultation with the community, and should include road improvements at the side of Loch nan Drumnain. Only one option actually creates a village by-pass, whereas the other two merely straighten the road north of Kilmelford and would thus increase average speeds of traffic entering the village.
- j) This Community Council requires clarification as to the definition of 'minor settlements', notably in respect of the housing areas at Scammadale and Loch Avich
- k) The areas occupied by Kames Fish Farming Ltd, at Kames shown on map 5/B/1/30 on page 92, should be classified as 'Established Business and Industrial Areas' (similar to Kilmelford Yacht Haven), as the fish farm has been established for over thirty years. This should be divided into the Fish Farm premises at kames, and also Kames Pier.
- 1) This Community Council wishes clarification on how the Coastal Constraints zones were derived, since map 5/A/2/2 on page 55 shows a constraint zone at Kames Bay, where a cage site has existed in continuous operation for over thirty years. It is the Community Council's view that that the Constraint Zone should cover the entire Northern shore and the Eastern end of Loch Melfort, with no additional fish farm development permitted within the loch (apart from continuation of current operations).

While the Community Council appreciates the level of effort put into this consultation document, we feel strongly that it would be useful for the authors of future drafts to consult directly with the Community Council in relation to the different classifications of areas, development or otherwise.

From the above list, you will be aware that there are a great number of areas requiring clarification and further review. This Community Council considers it essential that sufficient time, resources and Argyll and Bute

Council guidance be provided to allow effective consultation prior to formulation of any final document.

We look forward to hearing your response to the above representations.

BROADBAND FOR KILMELFORD EXCHANGE

Only 30 households / businesses needed to register to get Broadband

We currently have 17 Registrations - ONLY 13 MORE TO GO!

On speaking to Gary Carr a BT Broadband representative I have managed to find out a bit more information regarding the Broadband service for anyone who still might have questions.

Since contacting a number of people within the area, it has come to my attention that maybe people feel they will have to see it through and sign up for the service if they register.

I have been assured that this is not the case! So even if you are not sure if this service is any good for you, please help others in the village to get it.

You are NOT committing yourself to Broadband by registering but simply helping BT recognise that they need to install the service.

Once we have reached our target, BT will set a date for installation, which is usually anywhere up to about 2 months.

BT will then contact you, to see if you would like to sign up for their Broadband Service. (At this stage you can choose who you go with)

You may have changed your mind and not want Broadband anymore.

THAT'S FINE IT WILL NOT AFFECT ANYTHING.

If you are struggling to register due to distance I have been told it is because the distance measured is actually the length of cable used and not necessarily how far you are away from the exchange. But do not despair, I was also told that once Kilmelford was upgraded for Broadband, the next step for BT it to extend the distances. Before you do give up hope call 150 and ask them to test your line for distance, it may be down to a computer error and is worth double-checking.

Gary Carr of BT mentioned that they are committed to bring Broadband to the area. He has not heard anything to suggest that this would not be the case if we reach our target, and that all we have to do is get everyone to put their names down regardless, and keep in touch with BT for installation dates.

ARDUAINE GARDEN

With the rapid approach of spring, I'm hoping to persuade our readers that a visit to Arduaine Garden should be on everyone's list of things to do. It's not every community that has a garden of national (or even international)

repute right on its doorstep, but sometimes that very proximity works against us here at the garden - people tend to explore further afield and beyond their own backyard.

For those of you who may not know the garden, we have a very large collection of around 400 distinct rhododendron species, many tender, from all the rhododendron hotspots of the world, particularly the Himalayan region (including India, China and Bhutan) and further south into Burma and Vietnam. Other species come from Europe, Japan and North America, and Australia's only rhododendron and several of the sub-tropical species from Indonesia grow in the conservatory here. We have also a large and expanding collection of plants from South America, including Chile, Argentina and Brazil and several representatives of the flora of Australasia and South Africa - we even have one conifer from the mountains of Ethiopia. I believe that Antarctica is the only continent not represented, but we're probably not unique in this respect!

As well as the extensive tree and shrub collection which includes many camellias, azaleas, magnolias, embothriums (the Chilean firebush), gevuina (the Chilean hazel - a relative of the protea) eucryphias, hoherias and many, many more, our range of perennials is also wide, both in natural origin and flowering period and consists generally of wild species or unimproved cultivars. In other words, we don't go in for huge, double or flamboyantly striped flowers, but prefer to stick to more natural and informal plants. Some of our more spectacular perennials include the blue poppies and the huge lilies from the Himalayas and the giant forget-me-not from Chatham Island in the South Pacific, but we have many tiny treasures too, such as the low-growing parasitic plant, purple toothwort, in flower at the moment. Ferns, including tree ferns, mosses, climbers and water plants complete the picture to ensure that there is something to see every day and something in flower whenever you visit - you may have to look a little harder on colder days!

Just in case you think that we are advertising our business free of charge, can I remind readers that The National Trust for Scotland is a registered charity set up to safeguard Scotland's Heritage for all to enjoy. It is not funded by government and relies on entrance charges, membership fees, donations and legacies to pay for the management of the growing number of properties of all types throughout Scotland, including castles and stately

homes, city tenements, small houses and vernacular buildings, gardens, battlefields, vast areas of the countryside and coastline including many islands, viewpoints and much, much more. In most properties the income fails to come near to the expenditure and Arduaine is no exception. For this reason we can't offer free or discounted entry to local people as we need every penny to keep this garden open for you and other visitors to enjoy. The NTS may appear to be a wealthy organisation but this is not the case our properties are generally inalienable and cannot be sold, so are liabilities rather than assets. All profit we make from our commerce goes back into conservation work for the benefit of all, so no-one gets fat on the proceeds!

Our charges for 2004 are as follows: Adult - full - £5.00, concession - £4.00, Family Group - £14.00 (2 adults and up to 6 children). Membership charges available on request - 01852 200366.

As with other areas of Scotland, Argyll has a Members' Group which organises a number of events and visits throughout the year to help to raise money for local Trust properties - they have been very helpful to Arduaine Garden on numerous occasions.
