The Seil scheme is a great success with a considerable demand for the service it provides – they now have 16 volunteer drivers and 26 passengers. The scheme has been re-named and is now known as the North Argyll Voluntary Car

Scheme to accommodate their expansion plans to cover, not only the remainder of the Easdale medical practice area, but also the Dalmally area.

Volunteer drivers are needed in order to expand the scheme into our area – training is given, a mileage allowance and out of pocket expenses are paid and people can offer as much or as little time as they wish. However supportive friends and neighbours may be, such a scheme removes the onus from those in need of transport of having to ask favours.

#### LETTER FROM OUR MINISTER

Dear Friends,

May I, through the Kilninford News, give you an update on the Kilninver Appeal.

Thanks to the warm-hearted response of so many people with Kilninver connections, we have raised over  $\pounds 20,000$  and are now going ahead with the necessary roof and other repairs to secure the future of our Church building. By the time you read this scaffolding should be in place and there should be visible signs of the work going ahead. If everything goes to plan, the repairs should be nearing completion before the end of the year.

The Kirk Session and all the members of the Church have been greatly encouraged by the generous response to the appeal and say a very appreciative thank you to everyone who has contributed in any way to the appeal.

In Kilmelford we are preparing for the Parish Lunch, and details of this should appear elsewhere.

There are repairs needing to be done in the building at Kilmelford, and a similar appeal to the community and to all with Kilmelford connections will be necessary some time in the near future. The Kirk Session hope that we will have the support of the community to a similar extent. Watch this space for further news!

The Presbytery of Argyll is looking at the provision of ministers throughout its bounds and particularly in connection with the retiral of Freda Marshall from the neighbouring parish of Kilbrandon and Kilchattan. Much discussion will have to take place, but it is hoped that something concrete will be on the table within the next few months. Whatever is decided, it will have consequences for Kilmelford and Kilninver, so we will have our part in the discussions. Again, watch this space!

Meanwhile, as a busy summer comes to an end, many of us can begin to draw a breath and plan for the next one. Such, I am discovering, is life in Argyll. May God bless you in all that you do.

#### **RECYCLING FACILITIES**

The recycling facilities at the Kilmelford Village Hall now cover plastics, bottles, cans and fabrics. A house to house paper collection takes place every second week and bins can be obtained from Argyll and Bute Council. To ensure the continuation of these facilities, it is vital that they are used as much as possible (come on, it's everyone's social responsibility!), but most importantly, used properly. There have been examples of non-recyclable material left in the car park, which only means that someone else has to tidy up. Large items of domestic waste should either be taken directly to the council tip, or retained until the bulk refuse service returns (dates are published in the Oban Times and in Kilmelford Post Office). Please can everyone ensure that only the correct recyclable material is placed in the relevant container, and that no rubbish or waste material is left alongside.

> THE FIRST MEETING OF THE NEWLY CONSTITUTED COMMUNITY COUNCIL Tuesday 19<sup>th</sup> April 2005 at 8.00 pm in Kilmelford Village Hall

Also present were 19 members of the public.

1) Councillor Macaskill of Argyll & Bute Council reported on the election of the above Community Councillors. A vacancy still exists for the Kilmelford region, which may be filled by holding a further election. Cllr Macaskill called for nominations for a Chairperson. Neil Manchester was nominated by Robin Asbury, seconded by Robin Grey and duly appointed as Chairperson.

The remainder of the meeting was chaired by Neil Manchester.

The chairman began the proceedings by thanking the members of the previous Community Council for all the work they had done during their time on the Council.

Apologies: Cllr MacIntyre, G. Dalton

2) Filling of vacancies on the Community Council; the chairman suggested a ballot at the next meeting in June to elect one more councillor from the Kilmelford area.

- 3) Report from previous Community Council meeting held on 8th February 2005.
- i) Matters Arising
  - a) Regarding the matter of the land opposite the Hall being adopted by Argyll & Bute Council for additional parking, Cllr Macaskill advised that this was most unlikely to occur. He suggested that Mr Tilley should firstly be asked if he were willing to sell the land. It may be possible for the Community Council to apply for a grant towards its purchase.
  - b) Community Council notice board no further progress. To go on the agenda for the next meeting.
  - c) Regarding the Inverliever Wind Farm, a letter of objection to the planning application has been sent.
  - d) The proposed 20 mph speed limit outside the school no further action has been taken.
- ii) Planning applications from the last meeting:
  - a) The Lagganmore Estate applications Cllr Macaskill reported that one of the applications was likely to be recommended for approval with strict conditions attached.
  - b) Application for a dwelling on the land west of Pier cottages nothing to report.
  - c) Application for a dwelling at Arduaine campsite the Community Council had recommended in writing that various conditions should apply, but the chairman reported that the planning application had breached these conditions.

Cllr Macaskill advised that the final version of the Lorn Local Plan would be out in May 2005.

4) Model Constitution

There will now be six councillors on the Community Council instead of seven. They will serve a maximum of four years in office instead of three. The Constitution will otherwise remain the same as before.

5) Model Standing Orders – these are to be the same as before.

6) Appointment of Chairman – already done.

7) Appointment of Vice-Chairman – the chairman suggested that this was not really necessary; in the case of the chairman's absence, one of the other councillors would be able to chair the meeting.

8) Appointment of Secretary. There were no nominations for secretary. The chairman decided to leave the matter until the next meeting, when an additional councillor was to be elected.

9) Appointment of Treasurer. Robin Grey was nominated by Neil Manchester and seconded by Robin Asbury and duly appointed as Treasurer.

10) Appointment of Planning Liaison Representative. Alasdair Oatts was nominated by Neil Manchester and seconded by Robin Grey and duly appointed as Planning Liaison Representative.

11) Appointment of Signatories for Bank / Building Society accounts. These are to be the Chairman, Treasurer and the Secretary (when appointed).

#### 12) Any Other Business

- a) Diarmid Campbell commented that, regarding the Degnish Road, he had read in the minutes of a previous meeting that "this road is at capacity". He expressed the view that the Degnish Road did not carry as much traffic as some of the other roads in the area. The chairman replied that the mention, in the minutes, that the Degnish Road was at capacity, reflected the views of those present at the meeting to discuss the Draft Lorn Plan.
- b) Dorothy Carmichael reported that no railings had been erected around the bus stop to prevent children from running into the road. The chairman answered that the work was not yet finished and that the final plans for the bus stops are not known to the Community Council.
- c) Anne Saunders suggested that a bus shelter of wooden construction would be more attractive for Kilmelford than the plastic type. Cllr Macaskill advised that this was not within the remit of the contractor working on the bus shelters. The Community Council would have to arrange this themselves with the possibility of a grant being available towards the cost. This is to be looked into.
- d) Elizabeth Asbury asked if anything could be done to make the Kilmelford car park more attractive. Cllr Macaskill advised that the Community Council could make changes to the car park with the approval of Argyll & Bute Council, but to bear in mind that, as it is a typical housing infill site, A& B Council could take it back at short notice. This would necessitate the siting of the bus stop elsewhere. The matter is to go on the agenda for the next meeting.
- e) Regarding the new Lorn Local Plan, the chairman said that a public meeting will be held to discuss the plan when it is published.
- f) Angus MacFadyen asked about the Inverliever Wind Farm planning application. Cllr Macaskill reported that the plan had not yet gone to the Area Committee.
- g) Angus MacFadyen reported that, although some of the damage to the Scammadale Road had been made good, it had still not all been repaired.
- h) Cath Manchester asked if anything more had been done regarding the possible "Heart Start" scheme in Kilmelford. The chairman replied that there was no further progress.
- i) Anne Saunders mentioned that on Macleod's original plans for the Glebe, a play area for children was to have been included, but had not so far been provided. Cllr Macaskill replied that Macleods would have to comply with this unless a subsequent application had been submitted. He did not have any further information at present, but would look into the matter. Ann Saunders considered

that the proposed siting of the play area near the burn was not safe for children. This will be an item for the next meeting.

13) Date of the next meeting and the A.G.M - Tuesday 14<sup>th</sup> June 2005 at 8 pm in Kilmelford Village Hall.

There being no further business, the chairman closed the meeting at 20.40.

2. Minutes of the meeting on 19th April 2005

Neil Manchester, appointed as Chairman at the previous meeting, chaired the meeting.

The Minutes of the Meeting of the 19<sup>th</sup> of April were discussed.

Item 12: Councillor Macaskill stated that in this item where it said 'Council' it should say 'Area Committee'

3. Matters arising from the last meeting

a)-Vacancy on Community Council

Councillor Macaskill had pointed out that the constitution required an election.

b)-Appointment of Secretary

Neil Manchester then brought up the issue of the need to elect a Secretary for the Community Council and Stewart Cannon agreed to be Returning Officer and handle the election. He stated that he was not intending to stand himself. An interim Secretary was co-opted; Diarmid Campbell, proposed by Neil Manchester and seconded by Alasdair Oatts.

c)-Land at Kilmelford Village Hall

The adoption of the ground adjacent to the Fire Station and across from the Hall was brought up. Councillor Macaskill had stated that the Council would not adopt or purchase the ground. James Adam stated that the ground belonged to John Tilley. Robin Asbury agreed to write to Mr. Tilley on the subject.

d)-Community Council Notice Board

The Community Council Notice Board had now been erected at the Post Office.

e)-Bus Bays at Kilninver and Kilmelford

Kilmelford: Councillor MacIntyre stated that this week on the 16th and 17th of June the new bus shelter was to be installed. When asked whether there could be matching shelters, Councillor Macaskill stated that the Kilmore shelter was the style. Councillor MacIntyre stated that the new shelters were all the same throughout the Highlands and Islands, installed by Hi-Trans.

The Rev. Alasdair MacLachlan raised the issue that the Trustees of the Church of Scotland were awaiting payment for the land sold to the A&B Council for the bus bay. Councillor MacIntyre agreed to pursue the matter.

Kilninver: The landowner has been found to be living on Seil. Councillor MacIntyre will be talking to him about land for the bus bay in person since he has not answered correspondence. f)-MacLeod's Glebe Completion Issues

Councillor Macaskill stated that the issue was being followed up.

#### 4. Argyll and Bute Local Plan- Final Consultation

The copy of the document / Plan given to the Community Council would now be placed in the Post Office to be examined by members of the community. The Plan is also on the A&B website. There will be a special meeting held in the first week of July to discuss the Plan. Robin Asbury mentioned that he had inserted tabs on the pages relevant to the Community Council area so as to make it easier for people to find those plans.

Neil Manchester stated that the Meeting to discuss the Community response to the proposed Plan would be held at 8 pm on **Tuesday the 5<sup>th</sup> of July in Kilmelford Village Hall.** Until then the Document is to be kept in the Post Office in Kilmelford.

#### 5. Planning Applications

Alasdair Oatts reported that there were the following items:

- 1) Forest Grant Scheme at Raray
- 2) Erection of another 15 m. high mast and installation of Telecom equipment by 'Orange' west of the existing mast at 'Degnish'. The fact that there was not a mast at Degnish was brought up and he agreed to investigate.
- 3) Erection of two dwelling houses on plots A and B northwest of Barochreal at Kilninver by Mrs. Angier.
- 4) Erection of a dwelling house on land northeast of Degnish point by Hugo Struthers.
- 5) Non material amendment to consent at Eathie by Arduaine, Dr. & Mrs. Angus McCross.
- 6) Installation of a dormer window to form a bathroom at Barn cottage, Lagganmore by Bill Campbell.

Other than the question about the proposed site of the 'Degnish' mast, there were <u>no comments or</u> <u>objections</u>.

The question of the windfarm at Inverliever was raised by Robin Asbury. Councillor Macaskill would not be drawn on the decision since there was still a meeting to come in August, probably at the Corran Halls.

#### 6. Correspondence

Alasdair Oatts asked Councillor Macaskill whether he could chase up A&B at Kilmory to start using the addresses of the new Community Councillors that had been sent to them. Neil Manchester confirmed that additional e-mails had been sent making Kilmory and Oban offices aware of the new Community Councillors and their addresses.

Wildflower Courses:

The course will be attended by local representatives on the 21<sup>st</sup> of June at the Hotel. Only two places are left but there is another course at Taynuilt.

#### 7. Any Other Business

- 1) The road leading into the Glebe houses has had chips laid on the surface and these have been allowed to block the openings to drains. Councillor MacIntyre will contact the road people.
- 2) At the Scammadale to main road junction the crossing sign was taken down but has not yet been put back up again. Neil Manchester will contact Neil Brown.
- 3) A question as to whether the Timber Extractors on Scammadale road have been told not to use the road during the times when children are going to or from school. The License to Extract was turned down.

- 4) The Rev. Alasdair MacLachlan asked who had installed the football pitch on the Glebe and was told that it was his predecessor the Rev. Mike Erskine. In that time the land was more used as it was organized for a local team.
- 8. New Business

Glebe:

The Rev. Alasdair Maclachlan brought up the issue of the Glebe below the Manse: He stated that the Trustees of the Church of Scotland would be willing to sell a part of the Glebe to the Community Council as a recreation area if they would be interested. They were anxious that the Glebe land be used for community purposes and had no desire to maintain the Glebe land. Neil Manchester thanked him for the offer and it was agreed that this item be put on the agenda for the next meeting in July.

There was comment that ideally a recreation area if owned by the Community Council should be near the Village Hall and so run by the Hall Committee, however the committee had not been able to obtain land adjacent to the Hall when they tried. Jane Rentoul commented that there was more level land at the Glebe than at the Hall. Alasdair Oatts brought up the issue that any change would need to be discussed with the agricultural tenant who grazed the Glebe on an annual lease. Stewart Cannon raised the issue of who would maintain the Glebe land if it were to be under the Community Council. The Glebe issue was to be placed on the agenda for the next General Meeting.

#### The Bus Park

Elizabeth Asbury raised the issue of improvements to the Bus Park. Councillor Macaskill pointed out that it was leased by the Community Council from A&B Council. He asked whether the £1 a year rent was being paid. Neil Manchester replied that it generally was. Elizabeth Asbury stated that following the desire of the Community Council that the site be improved, she had visited the site with Diarmid Campbell and they had noted some possible improvements including re-grading and re-gravelling the area so that the water did not drain into the Bus Shelter. Diarmid Campbell suggested that the improvements be discussed with the immediately adjacent neighbours before anything was brought before the Community Council. Elizabeth Asbury agreed to show the draft plan and photo/sketch ideas to the neighbours.

#### Dial a Bus

Councillor MacIntyre gave the Community Council pamphlets on Dial-a-Bus. This was also to be put on the agenda for the next General Meeting.

#### 8. Date of Next Meeting

The next General Meeting of the Community Council will be held on Tuesday 9th August 2005 at Kilmelford Village Hall.

The Meeting was closed by Neil Manchester at 8.45 pm

2. Minutes of the Annual General Meeting held on the 8<sup>th</sup> of June 2004

The Minutes of the previous Annual General Meeting were read. There were no additional comments. Approval was proposed by Stewart Cannon and seconded by Neil Manchester.

#### 3. Chairman's Annual Report

Neil Manchester as Chairman stated that the elections had been completed. There were significant changes. The previous members of the Community Council had served long and well and it was good to see some of them attending the current meeting. He then listed items that they had achieved under the Chairmanship of Angus for the previous year:

- 1) Resisted the Mussel Farm invasion, demonstrating that community democracy was the best means to control such development.
- 2) Made useful comments on the first draft of the Local Area Plan
- 3) Controlled and reviewed Planning issues
- 4) Continued the ongoing discussion on Wind Farm issues

For the new Community Council these issues continue to be important. Future issues include:

- 1) Submissions on the Local Area Plan
- 2) Continuing general Planning issues
- 3) Car parking at the Hall and Bus Park
- 4) Windfarm renewable energy issues

Neil Manchester stated that he looked forward to serving as Chairman, being keen to share responsibilities and the workload among the Community Council. He then thanked the outgoing and incoming members of the Community Council for their service and volunteering, and Councillors Macaskill and MacIntyre for their services and members of the public for their support of the Community Council.

4. Treasurer's Report

(Attached) Robin Grey reported that there was an excess of £201.82.

5. Approval of Accounts

Robin Asbury proposed that the Accounts be Approved, Jayne Brown seconded.

The issue of whether the Community Council would receive a lump sum from A&B Council this year was discussed. Councillor Macaskill stated that it would be paid as an increased grant but increased from the previous year. The sum of £300 was mentioned.

Neil Manchester gave a vote of thanks to the A&B Council.

6. Election of Officers 2005-2006

Neil Manchester; Chairman (No Vice Chairman) Robin Grey, Treasurer Jayne Brown Robin Asbury Alasdair Oatts, Planning No Secretary had been elected, Diarmid Campbell was co-opted as interim or acting Secretary.

7. Any Other Business

Shiela Cannon had agreed to be Auditor of Accounts. Her appointment to do so was proposed by Neil Manchester and seconded by Jayne Brown.

8. Close of Meeting The Meeting was closed at 9 pm.

#### \*\*\*\*\*

An ordinary general meeting of the Community Council was held on Tuesday 9th August 2005 at Kilmelford Village Hall, with 3 community councillors and 17 public present.

The appointed Returning Officer, Stuart Cannon, announced that Diarmid Campbell had been elected for the remaining position on the community council. Mr Campbell was immediately proposed and seconded for the role of secretary.

Concern was raised over the completion status of the Glebe development, and it was agreed to place this on the agenda for the next meeting. Elisabeth Asbury presented proposals for landscaping the car park in Kilmelford, and discussion followed on the various options. Further plans will be presented at the next meeting, and hopefully an action plan formed. Councillor Macaskill reported that the new bus shelter in Kilmelford had not been erected as the founds did not fit the designated shelter. Robin Asbury outlined the 'dial-a-bus' schemes available, and it was agreed that an article be placed in the next newsletter asking for public opinion. The Reverend MacLachlan advised that the church had not received any monies for the land that the new bus bay was built on.

Planning issues discussed included the erection of a radio mast at Degnish point, the consultative draft of the local plan (representations from the community council submitted), and the planning departments recommendation that the Inverliever wind farm be refused. Also, the Scottish Water application for wastewater treatment works was discussed, and it was agreed that representatives be asked to attend a future meeting to answer any questions.

The meeting closed with discussions on the future of public call boxes (the community council will be consulted if removal is proposed, the recent beach cleaning by members of the Prince's Trust, and the continued use of the Glebe land as a sports facility.

A special meeting of the Kilninver and Kilmelford Community Council was held on Thursday 8th September 2005 at Kilmelford Village Hall. Five community councillors were present, and also 33 members of the public.

The first item under discussion was the Scottish Water wastewater treatment works, which commenced with an informative presentation by representatives of Scottish Water and the installation contractors. Areas of concern that were raised were: the overall cost and who is funding the project (Scottish Executive); lack of expansion opportunity (Scottish Water remit was only to service the existing Scottish Water Customers, plus an additional 16 houses already planned by McCleods); lack of consultation over scope of works (planning permission only required for landscaping and fencing works); provision for power failures since the system relies on pumped discharge (6 hours storage capacity with generator for back-up power if required); what do the remaining houses do? (await further SEPA directives, when additional funding may become available if upgrades are required for domestic properties).

Secondly, an application for outline consent for a dwelling house at Shore Cottage, Melfort was discussed. There was unanimous support for a community council objection on the grounds that the application area was in breach of the Draft Local Plan, and that caution must be exercised over increasing traffic volumes on the Degnish Road.

The final agenda item was an application for a restaurant by Melfort Pier. It was unanimously agreed that the community council object to this application on the following grounds: the Degnish road would not sustain an increase in commercial traffic; the application is in breach of the Draft local Plan; there are inadequate water supplies at Melfort for this type of development; this is another example of creeping, incremental growth, which both the Head of Argyll and Bute Council planning department and the Oban, Lorn and the Isles Area Committee have pledged will not be allowed to continue on this site.

The meeting closed with brief discussion on street lighting in Kilmelford, which will be addressed at the next ordinary general meeting.

"For now shall I sleep in the dust" (Job 7. 21)

Green Angel Hill, of lovely pose, Near where dark Euchar swiftly flows Amongst Kilninver's bonnie knowes Toward Loch Feochan's peaceful shores. The glen sweet nature has adorned With heath-clad dales and hazel groves, I do not see the wide world o'er A place my heart so much adores.

There memory keeps one spot e'ergreen, 'Tis deeply in my heart enshrined, And yet it hath neglected been. At night this haunts me in my dream, Green Angel Hill, it gars me greet Here, far away, and cannot keep That hallowed place in order neat, The mound 'neath which my father sleeps.

Blest souls of dear departed friends Have reached yon realms where joy ne'er ends; But if at times they did return 'Twould be enough to make them mourn To see those places so forlorn With weeds and nettles all o'er grown. Green Angel Hill would them deplore How different 'twas in days of yore.
