# **UPDATE – KILMELFORD YOUTH CLUB**

It has been some 4 months now since Kilmelford Youth Club Committee commenced the Club Nights every Wednesday at Kilmelford Village Hall. It has been considerably longer, however, since the Committee formed and started discussing what we felt would be a useful and valuable service to the children and young adults of our area. A great deal of effort has gone into the formation of the Youth Club and this continues as we work together towards obtaining proper Disclosure.

At the time of writing we are still waiting for Disclosure Scotland to formally recognise our Club. Once this has taken place, then each volunteer will submit their details for Disclosure Scotland to verify against

police files. Until we have the correct recognition we cannot apply for funding or take advantage of the many services/activities which are available locally. At a recent Committee meeting, it was decided that we would cease Club Nights for the time being but will recommence in the New Year when we have our disclosure status. The Committee continue to work behind the scenes to ensure that this will happen.

We aim to provide a meeting place for local young people to meet and learn new skills from willing volunteers. We hope this will include sports activities such as football, kayaking, dancing, archery etc, as well as learning new arts and crafts, computer skills, chess, backgammon and learning about nature by enjoying short field trips and having group adventures.

We have been overwhelmed by the sheer numbers of children arriving at Youth Club, which although it illustrates clearly that there is a need for this facility, has presented us with a problem - we simply do not have the numbers of volunteers to assist us in offering these activities and to ensure the safety of the children in our care.

We are very keen to recruit volunteers from the local community. Please, please, if you can spare a few hours a month to help our youngsters, we would urge you to contact Anne Saunders, at the Village Shop.

In the meantime, all the young people and Committee of Kilmelford Youth Club, would like to thank everyone who has given their time to assist at Club nights over the past few months. We have received generous donations from local organisations and would also like to thank those involved for their generosity. ### LETTER FROM OUR MINISTER

At the beginning of November the repairs started at Kilninver Church. After the Community raised nearly £20,000 for these repairs and we sourced a contractor who was willing to do the work according to our budget, the works began. It is hoped that the roof will be wind and watertight and the belfry conserved, plus some other external work all completed by the end of the year. I am still deeply appreciative of all the hard work done by the officebearers of the Church in seeing the Appeal through to its conclusion and of the generosity of all the community and their desire to see the Church remain as a useable feature of the Parish. We would love to see the lighting in the Church brought up to the standards required for Disabled Access, but the sum raised by the Appeal is not enough to meet this cost. Perhaps some of you might be willing to help towards this end.

A reflection of the Community's desire was the very happy event in the middle of November when Angus Kennedy was baptised in the Church. Angus is the grandson of Vanessa and David Kilpatrick, and his parents were particularly keen to have him baptised in Kilninver, because of the family connections. I hope this will be a sign the continued use of the Church for family events such as this, set in the context of the worship of God.

Christmas is now very nearly on us and preparations are well under way for the usual services. A note about these will be found elsewhere. I recently saw a large banner proclaiming "Christ is the Reason for the Season." Those of us who know Jesus Christ as Lord and Saviour approach Christmas as the time to remember that God loved this world and everyone in it so much that he sent his only son into the world in order that all who believe in him might have a new and everlasting life. To me Christmas is a huge confession of faith in each one of us as being of infinite worth to God, and a reminder that Jesus has shared our human life, so that there is nothing in life that is not of interest to God.

I hope that you have a very happy time, for we in the Church will. I do not wish you Season's Greetings, but a Very Happy Christmas and a Good New Year.

Committee meetings of the above association were held on 13<sup>th</sup> September and 8<sup>th</sup> November 2005 and the main topics discussed were:

### Caretaking duties

The search for a Hall Caretaker continues. In the meantime the members of the committee are carrying out the caretaking duties in a rota. A cleaner is still required. A thorough "Spring Clean" of the Hall by volunteers was organised for the end of November.

### Maintenance

The back door and doorframe have been replaced at an estimated cost of  $\pounds 680.00 + VAT$ . Replacement light bulbs for the theatre lights have been purchased at a cost of  $\pounds 80.48$ . The new tea urn is in use. The cost was  $\pounds 89.70 + VAT$ .

### Fund Raising

The Treasurer emphasised the need for more fund raising activities to cover the costs of recent and future expenditure. The level of donations to the Hall fund is down compared to previous years. The planning of the Beetle Drive and Hogmanay Party were discussed.

# KILNINVER AND KILMELFORD COMMUNITY COUNCIL

# **DRAFT MINUTES**

A meeting of the above Council was held on Tuesday 9th August 2005 at Kilmelford Village Hall.

**Present:** Community Councillors: Neil Manchester (Chairman), Robin Asbury, Robin Grey Also in attendance were Argyll and Bute Councillors Alan Macaskill and Duncan MacIntyre and 17 members of the public.

### **Apologies:**

Apologies were received from Diarmid Campbell, Jayne Brown, Alasdair Oatts, Ian and Meriel Tegner, Anne Grey, Christine MacLachlan.

### 1 Minutes:

The minutes of the meeting held on Tuesday 14th June 2005 were approved and signed, subject to an addition requested by Councillor MacIntyre: Under item 7.3, The licence to extract timber from Scammadale Forest had been approved, but the use of the road had not been approved by Argyll and Bute Council.

# 2 Matters Arising:

Mr Stuart Cannon, Returning Officer, advised that the results of the election for the vacancy on the Community Council was as follows:

Mr John Stannard	31 votes
Mr Diarmid Campbell	34 votes

The chairman thanked Mr Cannon for his efforts, and noted that Mr Diarmid Campbell had been elected to the Community Council. The chairman proposed that Mr Campbell be appointed as secretary, seconded by Mr Robin Asbury.

Mr Asbury advised that he had written to John Tilley regarding the land adjacent to the village hall, and had received a holding letter noting that a delay was likely.

Cllr Macaskill advised that McLeods had indicated that the roads and play area would be completed shortly. Cllr Macaskill agreed to report on progress at the next meeting.

Mrs Elisabeth Asbury displayed photographs and plans for the proposed development of the car park in Kilmelford. Mr Colin Clark advised that there was an underground high voltage cable that was near the surface and would prevent significant levelling of the car park. Cllr Macaskill noted that the Council would consider any landscaping application, and that the Area Committee may provide a grant. Mrs Asbury and Mr Campbell agreed to develop the plans and cost the project in detail. Mr Clark felt that the car park should incorporate a bus bay for added safety.

Cllr MacIntyre advised that the bus shelter on the opposite side did not fit the foundations laid when the bus bay was constructed, and that there was a dispute over responsibility. Mr Robin Grey enquired as to the status of the bus stop at Kilninver School. Cllr MacIntyre advised that plans were progressing.

Mrs Jane Rentoul asked whether any progress had been made over the Dial-a-Bus scheme. Mr Asbury outlined the details of the scheme, and Cllr Macaskill reported that this had been successful elsewhere. Fiona Wyllie agreed to place an article in the next newsletter to ascertain community support.

The Reverend Alasdair MacLachlan advised that the church had not received any payment for the land used for the Kilmelford bus bay. Cllr Macaskill advised that payment had been due in August by Hitrans. Cllr MacIntyre advised that authorisation had only been given in August, so would be due shortly.

Mr Asbury advised the meeting that he had sought clarification of the recent application for a 15 metre high mast, and advised that the application had been passed by the Council, and that the mast was at the end of the Degnish Road but concealed between the hill and some trees.

# 3 Argyll and Bute Local Plan - outcome of meeting on 5th July 2005

The chairman advised of the letter sent following the final community consultation meeting on 13th July 2005. Cllr Macaskill advised that the draft plans and representations were with the Council and awaiting approval, after which the final version would be submitted for a final consultation period.

### 4 Scottish Power Wind Farm Application at Inverliever

The chairman reported that the Argyll and Bute Planning Department had recommended that the application be refused. Mrs Diane Scaife asked whether the Community Council would be represented at the public hearing. The chairman felt that this would not be necessary, and asked the members of the

public if they felt that representation was required. There was no response. Cllr Macaskill advised that there would be a full council meeting on site, with presentations made in the afternoon by the Planning department, the applicants, objectors and statutory consultees, which could include community councils if they wish.

# **5** Planning Applications

Mr Asbury reported on the Waste Water treatment plant in Kilmelford, and outlined the scope of the development. Mr Stuart Cannon asked whether the plant would accommodate all the houses in the village. Mr Asbury noted that the plant would service the Glebe development and the council houses in the village. Mrs Claire Howard asked whether private septic tank owners would have to pay for treatment systems. Cllr MacIntyre advised that Scottish Water was acting under new regulations to replace existing Scottish Water systems by 2006. It was considered that involving SEPA to put pressure on Scottish Water to incorporate all houses may backfire on householders not covered under the Scottish Water system. Cllr MacIntyre suggested that representatives of Scottish Water be invited to present the plans in detail, and to answer any questions at an open meeting. The chairman agreed to organise this.

# **6** Correspondence

The secretary drew attention to a range of documents, leaflets, various minutes and agendas available for public review.

In addition, the secretary reported the following:

Fountain Forestry: timber felling in Scammadale was at the half way stage.

Argyll and Bute Council: notice that the 20mph speed limit at Kilninver was progressing, and would be implanted shortly.

# 8 Any Other Business

Alasdair MacLachlan advised that the continued use of the Glebe land for football was acceptable, and advised that further developments were a long way off.

Claire Howard asked whether there were plans to replace the red call box in the village. Cllr Macaskill advised that the Community Council would be consulted if removal was proposed.

Mrs Scaife reported that the Princes Trust members had carried out some beach cleaning as a service to the community, in return for use of the village hall for a course. It was agreed that a letter of thanks would be sent by Diane Scaife on behalf of the Community Council.

# 9 Date of Next Meeting

The next meeting of Kilninver and Kilmelford Community Council will be held in Kilmelford Village Hall on Tuesday 11th October 2005 at 8.00pm.

There being no further business, the chairman closed the meeting at 9.00pm.

# DRAFT MINUTES

A special meeting of the above Council was held on Tuesday 8th September 2005 at Kilmelford Village Hall.

**Present:** Community Councillors: Neil Manchester (Chairman), Robin Asbury, Jayne Brown, Alasdair Oatts, Robin Grey.

Also in attendance were 33 members of the public.

Apologies: Apologies were received from Cllrs Macaskill and MacIntyre, and Christine MacLachlan.

# 1 Application for Detailed Consent for Wastewater Treatment Works by Scottish Water (Planning Application Ref: WPC/N/72882)

Representatives of Scottish Water and the Project and Site Team were present to discuss the proposal. Public concerns raised included the cost of the project (£1.29 million, funded by the Scottish Executive), the limited capacity and failure to accommodate all septic tank outfalls in the village (designed to accommodate Scottish Water customers only, and compliant with the Urban Wastewater Directive in terms of percentage of the community covered), the fact that additional capacity was reserved for houses as yet not built on the Glebe (permission for development had been approved prior to the design of the wastewater plant, so had to be accommodated), and fears over the discharge of large quantities of raw sewage in the event of a power failure (provision of a duty and standby pump, plus provision for a generator to support a 6 hour storage capacity).

# 2 Application for Outline Consent for Site for Erection of Dwelling House by Mr and Mrs G A Brown (Planning Application Ref: 05/01694/OUT)

The details of this outline application were discussed, and a motion to object unanimously passed (proposed N Manchester, seconded Angus MacFadyen) on the following grounds:

In the Draft Local Plan, the area of the proposed development is in an area classed as 'sensitive countryside', and thus generally unsuitable for development. Approval could potentially create precedent for further applications

The community feel that the Degnish road is at the limit of its capacity to sustain further increases in traffic volumes.

# **3** Application for Detailed Consent for the Erection of Restaurant by Melfort Pier and Harbour (Planning Application Ref: 05/01750/DET)

The details of the Detailed application were discussed, and a number of points raised in objection. N Manchester proposed a motion that the Community Council objected to the application, seconded by Robin Asbury. The chairman asked for a show of hands to gauge public opinion prior to the Community Council voting on the motion. From a total of 28 votes cast, 21 voted for the motion, 3 voted against and 5 abstained. Given the level of public feeling, the Community Council unanimously voted to object to the application on the following grounds:

It has been stated previously that the community feel that the Degnish road is at the limit of its capacity to sustain further increases in traffic volumes. The applicant states that the proposed development would actually reduce traffic volumes, yet previous and current experience indicates that the increased volume

of visitors (during key eating times), plus the inevitable increase in delivery and refuse vehicles associated with this type of enterprise, suggest that traffic volumes would rapidly become unmanageable.

There is much local concern that the development will create an additional noise nuisance and will further exacerbate significant light pollution. In addition, the applicant is not providing additional car parking spaces for the new facility.

The Draft Local Plan, the Melfort Pier development is in an area classed as 'sensitive countryside', and thus generally unsuitable to development.

In response to the previous application by Melfort Pier, both Angus Gilmour and the Area Committee stated that this development had reached capacity, and that no further development would be permitted. This was reported in the Oban Times on 10th April 2003.

As per the Community Councils response to the Draft Local Plan, the infrastructure of this area is insufficient for further large-scale development. The water supplies for the existing development are barely adequate, and additional supplies are unavailable.

A question was asked regarding the plans for street lighting in the Glebe development in Kilmelford.

# ANGEL HILL BURIAL GROUND, KILNINVER (see poem in the September issue)

In reply to the enquiry from Duncan McIntosh, on the whereabouts of Angel Hill at Kilninver, the following may be of interest.

The late and much missed Donald Clark, who was born in 1904, referring to the old burial ground at Kilninver, said that in olden days it was sometimes called Angel Hill although the name had long since passed out of use.

It always seemed that this was an appropriate name for such a peaceful and beautiful place, from which there are splendid views out over the mouth of Loch Feochan to Kerrera and Mull.

There may, however, be another reason for this old name. The commanding position of this site could be a reason for it having been a place for a beacon to warn people in the district of danger.

The gaelic word Aingeal has two meanings, 'angel' or 'light or fire'. Any of these is appropriate to the name 'Angel Hill'; so it seems to be a case of take your pick unless, as is hoped, someone else can throw further light on the question.

There are two further points of interest. The enquiry came from Duncan Mcintosh, whilst the poem of 1904 was from another Duncan McIntosh. A third Duncan McIntosh is buried in Glasgow; he died on 23<sup>rd</sup> January 1879 aged 51 having survived by only 5 months his French wife Cecile Trupin who in turn lies on Angel Hill. One wonders if they are all related.

The other point of interest is that the view from the road at Kilninver was the subject of a poem by Wordsworth, who described it as if it were a stage with the curtains of Barnacarry and Minard hills drawn back to afford the view towards Mull.

The writer of these notes has seen the poem by the famous man but can no longer find it. Does any reader with a good library or internet access have a copy, as it would be interesting to see it printed in the next edition of the Kilninford News.

It should be noted that the poem by Duncan McIntosh of 1904 refers to Angel Hill as

' .....so forlorn with weeds and nettles all o'ergrown'

However, thanks to a restoration of the burial ground about 15 or 20 years ago, many of the headstones were re-erected by the Council. Careful maintenance by the Council since then means that Angel Hill is once again

'That hallowed place in order neat The mound 'neath which my Father sleeps'

as the poem of 1904 longed for.
