Committee meetings of the above association were held on 13<sup>th</sup> May and 1<sup>st</sup> July 2008. The main topics under discussion were as follows:

### Maintenance

- 1) The outstanding electrical tasks have now been completed; the shower and hand-dryer in the Ladies cloakroom are back in operation.
- 2) The committee are grateful to Fergus Gillanders, Hamish Gillanders, Robin Asbury and Chris Johnson for keeping on top of the grass-cutting and bank strimming. Many thanks!
- 3) The options available for supplementary heating in the main hall are being looked into, and an estimate is being sought for secondary double glazing in the entrance lobby.

# **Electricity costs**

- 1 )The existing contract for the supply of electricity with Scottish Hydro came due for renewal, but the new contract would have resulted in a colossal increase in electricity costs. The Treasurer has managed to negotiate a deal with Scottish Power for more favourable terms. Nevertheless, the Hall will still be having to pay considerably more for power in future than it did previously.
- 2) Owing to the raised costs, it will be necessary to increase the price of the heating tokens and review the scale of fees for the hire of the Hall to make ends meet. The new charges will come into effect on 1<sup>st</sup> October 2008 and will be displayed on the Hall noticeboard.

# **Fund Raising**

- 1) The popular Curry and Quiz Night in May raised £560.00. The committee would like to thank Elizabeth Asbury and Anne Grey for organising the meal so efficiently and successfully. Thanks also go to Toni Mitchell, Caroline Gillanders, Matthew Anderson, Jennie Campbell-Gibson, Robin Asbury and the others who contributed to the food and helped on the night.
- 2) Proceeds from the Mull Theatre productions go directly to the company itself. However, we make a small profit from the teas.
- 3) It is hoped that the Car Boot Sale on September 14<sup>th</sup> will raise some funds from the sale of pitches to vendors and the provision of refreshments.

# **OBITUARY – Lt Cdr Hugh Campbell-Gibson**

I first met Hugh Campbell-Gibson, who died recently, in 1938 when he and his mother came to tea, they came by boat so it was a fine day. Hugh was wearing his kilt complete with Glengarry, probably the same one you might have seen him wearing recently in the garden.

His naval career progressed as was normal for a product from the Royal Naval College, Dartmouth and was followed by service in a number of ships before promotion to lieutenant.

It was then that his career took an unusual twist in that he was appointed in 1947 as flag lieutenant to the commander-in-chief, Far Eastern Fleet, an Admiral hell bent on enjoying himself after an energetic war.

Hong Kong was the base, a cruiser flagship and a despatch vessel in which wives and families could follow the fleet. Hugh was responsible for seeing that all these facilities worked in accordance with the Admiral's wishes.

Subsequent naval appointments culminated in the desire of all naval officers, that of commanding one's own ship and this was achieved in 1956 when he was appointed in command of HMS Orestes, a minesweeper mainly deployed in Scottish waters with fishery protection duties, but which allowed time to anchor off his home in Loch Melfort, a somewhat similar ambition to that of being in command.

All good things come to an end and the subsequent appointment arose entirely by good fortune, that of resident naval officer, Machrihanish, not exactly onerous, for the air station was in care and maintenance.

Apart from administering the maintenance staff and representing the Royal Navy locally, there was time to think about after-life and learn about farming.

Kintyre was a most suitable situation to set about this task and the opportunity to shelter tups in the confines of the WRNS quarters, strongly fenced to keep sailors out, was even more efficient at keeping tups in.

In the mid-50's yet another defence review called for more redundancies. The money was good and Hugh decided to leave the navy and take up farming. This he did at Peninver ably supported by his wife, who he had married in 1949, and children who were by this time able to be of considerable help, for Hugh spent a number of days AWOL shooting.

After two farm cycles, about 10 years, and countless friends to stay, his wife Deirdre announced they might as well be running a hotel, and this is exactly what happened, selling up Peninver and buying Dunmor on the island of Seil, a house large enough to be a hotel and aligned with a farm somewhat similar in size to that at Peninver. The changes obviously required staff to help, but both Hugh and Deirdre were in constant attendance in the hotel where many old friends came to visit but of course paid their way and when on repeat visits encouraged to assist in the fanks or with the mowing.

When the family home became vacant, it was decided enough was enough and Dunmor was sold, Hugh's life then became concentrated on building up a garden which exposed colour throughout the flowering year. At this he was exceptionally successful. Tighnamara entered the Scottish Gardens scheme where he became the county organiser and subsequently a member of the executive committee. He also found time to be the senior steward of the Argyllshire Gathering in 1970 and an active member of the Association for the Preservation of Rural Scotland.

So in conclusion, we say goodbye to a naval officer, a farmer, a hotelier, a gardener and a man with a multitude of friends.

Over the month of August we held music evenings in Kilmelford Church and these were very well supported. All in all a superb response from both communities has enabled both myself and the Kirk Session to see long postponed renovations within reach of completion, and confidence restored that both buildings will be available for worship and community use for some time to come.

Historically, the Church has been a part of the inheritance of the area, and buildings that speak of the continued presence of Christian life and worship remind all who pass of the continuity of life and culture here. Although the congregations are small, the life of the church is still a vital feature of the inheritance. It gives me a great degree of personal satisfaction to be a small part of this work and witness, and I give thanks to God and to so many people in the community that the last years of my working ministry are being spent here.

#### KILNINVER AND KILMELFORD COMMUNITY COUNCIL

### **MINUTES**

The meeting of the above Council was held on 8th April 2008 at the Village Hall.

<u>Present:</u> Robin Grey (RG), Nigel Mitchell (NM), Lindsay Davies (LD). Also in attendance were Chief Inspector Fred Hall, PC Kevin Moffat and 14 members of the public.

**1.Apologies :** Robin Asbury, Alasdair Oatts, Cllr Donald MacDonald, Cllr Elaine Robertson, Jenny Moody, Angus McFadyen, Jane Rentoul.

Robin Grey (chair for this meeting) updated those present about the situation regarding vacant position of Chairperson. The Community Councillors have met since the last Community Council meeting and there are no proposals at present for an election. Robin Asbury as Vice Chair will assume the duties of Chairman in the meantime. With 5 Community Councillors there are no anticipated problems regarding achieving a quorum but legal advice is being sought on this matter.

**2. Minutes of previous meeting:** Minutes of the previous meeting, held on 12<sup>th</sup> of February, were taken as read. These were proposed by NM, seconded by LD.

# 3. Matters Arising from previous meeting:

- a. Roads Issues hedge at phone box- newly cut to satisfactory condition.
  - white lines at Degnish Road, Dalavich Road and parking bays in Kilmelford no reply at present. Carry over to next meeting.
- b. Speed Limit in Kilmelford- Procedure has begun to have this assessed. Require now to await assessment by A & B Council Roads department and Strathclyde Police. C.I. Hall added that traffic calming measures more effective than reducing speed limits.

Chief Inspector Hall took this opportunity to introduce himself. As the new Chief Inspector in Oban, Lorn and the Isles he is attending Community Council meetings to introduce himself to the localities. He hopes to attend meetings and encourage liaison with Community Councils. He is

encouraging the local police to be on the streets. He is prioritising the work against drugs and has established a drug squad. He is keen to improve the safety of the area.

- c. Bus Shelters in Kilmelford- not replaced. Carry over to next meeting.
- d. Blaran Road End- Awaiting report from Bus Company. Carry over to next meeting.
- e. Kilninver Notice Board- Grant of £275 approved. Awaiting payment.
- f. Weeds in Scammadale- no reply at present. Carry over to next meeting.
- g. Community defibrillator- Jeff Dawson from ambulance service has volunteered to come to June meeting to speak on this topic. Chairman asked for show of hands from interested parties. In view of poor response from those present, Community council will decide on further appropriate action.

# 4. Land around Kilmelford Village Hall.

Site meeting took place on Tuesday 1<sup>st</sup> April 2008, with 5 Local Councillors, clerk to the planning committee and Ian McIntyre, planning officer visiting the land in question. Ian McIntyre is in opposition to the proposal. The local councillors have produced resolutions supporting the proposal which have been forwarded to the Councils legal Department in order to be made competent in order for this issue to move forward.

# 5. Kilninver Primary School Staffing Issue.

LD read out letter from Kilninver School Parent Council to Ms Carol Walker, Head of Services for Primary and Pre-Five Education, highlighting a projected problem regarding pupil roll and staffing quota for academic year 2008-2009. With the current roll, the number of children on the date of assessment for staffing levels is expected to be 19 which would result in a change from 2.67 to 1.9 teachers. If the roll were 20 the staffing would remain unchanged. The letter asks for consideration of the teacher numbers not to be lowered because of the likely rise in numbers of children due to the Glebe development. The Parent Council would like the support of the community, Community and Local Councillors in this matter and will inform the Community Councils as to the response to this letter.

**1.Apologies :** Cllr Elaine Robertson, PC Kevin Moffat, CI Fred Hall, Cllr Neil MacKay, Dorothy Carmichael, Peter Menzies and Georgina Dalton.

**2. Minutes of previous meeting:** The minutes of the meeting held on 8<sup>th</sup> of April 2008 were taken as a true and accurate representation of that meeting. Proposed RG, Seconded Mrs. Toni Mitchell.

# 3. Matters Arising from previous meeting:

RA confirmed with Cllr MacIntyre new contact person for Roads etc. Stewart Clark.

Roads – No action on white lines as yet, to put in letter to Stewart Clark. Some potholes repaired, some to be done next week. Speed Limit – no response, carry forward.

Bus Shelter – old one has been removed, to action if not replaced in near future. It was noted that the timetable that has been recently put by the bus stop is out of date, RA to action.

Blaran Road End- no response from bus company. To carry forward.

Kilninver Notice Board- money granted in March not received as yet, Cllr MacIntyre assured cheque would be forthcoming in next week, he will take responsibility for chasing up. NM enquired re insurance. Cllr McDonald stated should be covered by insurance of landowner, however ACHA who own the ground stipulated at the time of proposing notice board that they would not accept liability. Cllr MacDonald to check re.liability.

Weeds in Scammadale – No action, to put in letter to Stewart Clark.

Community Defibrillator – Jeff Dawson, Scottish Ambulance Service, has been transferred out of the area. No replacement at present. To put on hold due to poor response at last meeting and lack of trainer in post. Cllr McDonald advised that the British Heart Foundation were funding 4 trainers, he will keep us informed.

Hedge planting in Scammadale- National Farmers Union have advised that planting of laurel is advised against but no legislation in place regarding its planting. It was noticed that many of the laurel planted have failed to survive. RG has discussed with Neil McCorkindale and Angus MacFadyen, no further action indicated.

Sight lines at Arduaine – Cllr McDonald stated ownership of boundaries still being established.

4. Land around Kilmelford Village Hall: RA advised that the Planning Committee have deferred a decision until August in order to consider the application regarding the Lorn Plan. Cllr MacIntyre confirmed pursuit of a competent motion would still be pursued in support of this proposal. A letter has been sent to M&K MacLeod regarding co-operation in joining footpath from the Hall to the new houses. A positive response was received very promptly and asking to be copied into future correspondence regarding the development.

- 5. Kilninver Primary School Staffing: LD updated regarding a response from Carol Walker, Head of Pre School and Primary Education. She stated the framework re staffing levels and acknowledging the Parent Councils concerns, which would be taken into account. The Headmistress has recently received confirmation of a primary school child moving into the area prior to the new academic year which will prevent the loss of a teacher as long as no families leave the area. The Parent Council will advise the Community Council should this issue arise.
- **6. Planning Applications:** AO advised there were 3 applications, 2 of which have already been granted permission, and none of which were contentious. These were:

Erection of dwelling house at Lagganmore, Scammadale. Permission already granted. No issues raised. Formation of an access track, land north of Barrachuile, Kilmelford. Permission already granted. No issues raised.

Construction of temporary road access, land south west of The Glebe. No issues raised.

# **7. Correspondence:**

RA advised of the following correspondence

- a) Oban Fire Station temporary Commander would like to make a presentation to Community Councils. RA to suggest October or December. The Fire service is trying to encourage members of the public to take advantage of Home Safety Visits.

- g) GRAB Trust leaflet covering eliminating food waste, beach and marine litter projects, green tip for the office, switching to re usable nappies and eco laundry balls. Further information can be found on <a href="https://www.grab.org.uk">www.grab.org.uk</a>
- h) Information from War Memorial Preservation Organisation detailing grants available. The war memorial in Kilmelford is owned by the Council therefore Cllr MacIntyre took this information in order to action.
- i) Community Engagement Meeting 19.06.08. NM and LD to attend.
- j) Public Document pack from A&B Council containing minutes of Area Committee meetings and minutes of Oban Harbour Development Inter-Modal Transport Sub-Group Meeting. Point of note-BT proposal to re-align payphone provision. It was noted that in the minutes CC's were to have BT's proposals circulated and we had not been in receipt of these. It was also noted that the pay phone in Kilmelford has been identified for removal. Attendees of the meeting felt this was a vital facility within the village due to poor mobile phone reception and was used by locals and visitors to tourist facilities within the village. RA to action this.

### **8. Any Other Business**

- a) RA referred to the availability of 'Wee Green Grants' which may be available up to £500. This could be relevant to Beach/roadside clean ups or developments behind the Village Hall. Re application can be made on a 3 monthly basis for as long as funds last, administered by CVS Invercible
- b) Glen Euchar House- still awaiting reply from Ian MacIntyre regarding the specifics of the planning permission granted.
- c) RA asked Cllr MacIntyre about current communication difficulties when dealing with A&B council. Firstly we have no contact list which makes initial contacts difficult, also we are currently experiencing difficulty re getting assistance, getting passed from one department to another, often going full circle and

finally not getting replies from messages left. Cllr MacIntyre will arrange for a current contact list to be sent to the CC. All departments to move into Oban Municipal Buildings which may help. To monitor.

- d) NM asked whether, in order to secure the negotiated price, he could go ahead and order Notice Board. All agreed.
- e) Dr Julie Forsay, GP at Easdale Medical Practice is moving to Australia. There will be a Strawberry Tea held in Seil Hall on 26.06.08 from 2.30-3.30pm. Posters to be put up at the hall and in Notice board.
- f) Deirdre Campbell-Gibson asked about the logs on the shoreline opposite their house. This could be hazardous should there be a high tide. RA to write to the owners of the logs requesting them be moved.

### MINUTES OF ANNUAL GENERAL MEETING

The Annual General Meeting of the above Community Council was held on the 10th of June 2008 at 9pm in Kilmelford Village Hall.

**Present:** Robin Asbury (Chairman), Lindsay Davies, Robin Grey, Nigel Mitchell, Alasdair Oatts, Cllr Duncan MacIntyre, Cllr Donald McDonald and 9 members of the public.

- **1. Apologies:** Cllr Elaine Robertson, Cllr Neil Mackay, PC Kevin Moffat, CI Fred Hall, Dorothy Carmichael, Peter Menzies and Georgina Dalton.
- **2. Minutes of AGM held on 12th June 2007:** The minutes of the meeting on 12<sup>th</sup> of June 2007 were taken as read. The minutes were approved by Alasdair Oatts and seconded by Lindsay Davies.
- 3. Matters Arising: Linda MacKinnon asked for the entry in the Treasurers Account named 'Cuilfail Cottages Rent' be detailed so as to indicate this is for the car park as discussed at last years AGM. It was noted that it is logged as 'Cuilfail Cottages' as this is what appears on the invoice. However it was agreed that in order to dispel any confusion it could be detailed to indicate 'car park'.
- 4. Chairman's Annual Report: The Chairman expressed that as with most Community Councils in most years the ongoing Planning Applications are a major area of discussion. This year two items dominated our discussions (a) the MacLeod's development in The Glebe and (b) the development of land around the Village hall. In the first case, A&B Council Planning Department noted our comments and one or two suggestions will be incorporated eg. protective fencing set back from the road during construction and appropriate and consistent fencing at the roadside on completion. As for the Village Hall Area we have had the full support from the Planning Committee, but not the chief Planner unfortunately, and we now only await the final outcome of the Lorn Plan to see if the way ahead is easier. A favourable response could see approval being given in August. Dealing with this has been time consuming and frustrating and as a result progress on the formation of a Land Reform Act Community Company has had to be sidelined until time permits.

In addition to these matters we have kept in touch with the Council, mainly Roads Department, over such matter as potholes, scrub clearance, passing places and footpaths and while some progress has been made the timing is so often resource/funding dependant. No doubt this will be a continuing saga.

I do not anticipate the work pattern to be significantly different in the coming year, the last for the current team, but we will continue to act as best we can in your interest. However, I would like to stress the need for the involvement of others in the voluntary work of the community if it is to continue successfully into the future. I will refer to this again under AOCB. It remains for me to thank Neil Manchester for all the previous work as secretary and Chairman until his resignation in February, my colleagues on the Community Council for all their hard work in different areas, our Councillors for their attendance and support, the Kilninford News Team for their efforts in researching, writing, reporting, printing and distribution of the three editions in the past year and last but not least, all of you who come and support our meetings with your views and suggestions.

**5. Treasurer's Report:** Robin Grey presented the accounts for the year ending 31<sup>st</sup> March 2008. It was noted that as per proposal at last years AGM the National Savings Bank Investment Account had been closed and lodged in the Bank of Scotland Treasurers Account. The planter project had been completed by Elizabeth Asbury and Toni Mitchell and there remained money available for this project if needed. The Football Club entry was from Robert Carmichael from the now obsolete Sailing Club Account. This has been passed on to the Kilmelford Football Club. Alasdair Oatts expressed thanks for this donation on behalf of the Football Club noting how grateful they were for this donation. The Football Club has recently been awarded a Fair Play Award. It was noted we closed the financial year with a balance of £1476.97.

The Chairman asked if this money could be used for development around the Village Hall. Cllr McIntyre confirmed that it could be used for whatever projects the Community felt appropriate. He also added that was worthwhile holding a balance in the account as it was often a requirement of grant givers that the Community provided "matched" funding.

- **<u>6. Approval of Accounts:</u>** The audited accounts were approved by Robin Asbury and seconded by Alasdair Oatts. The Chairman asked for our thanks to be passed on to Shelagh Cannon for auditing the accounts for this year, and proposed that Mrs. Cannon be asked to audit next year's accounts.
- 7. Election of Office Bearers 2008 /2009: The Chairman advised that all office bearers would stand down and the make themselves available for re-election. There was unanimous agreement to all office bearers being re-elected into their previously held positions. This was proposed by Nigel Mitchell and seconded by Cath Manchester. The office bearers for the forthcoming year can be confirmed as Robin Asbury Chairman.

# **8.** Any Other Competent Business:

- 1. The Chairman has been in contact with A&B Council regarding some proposed changes to the Community Council. There are two proposed changes-
  - 1) It is proposed to change our quorum as stated in our Constitution from 4-3.
  - 2) It is proposed to treat Kilninver and Kilmelford as one area not 2 sub areas for the purpose of election to the Committee.

There was unanimous agreement that these two proposals were in the best interests of the Community Council.

2. The Chairman pointed out that the Community Council Elections will be called in April 2009. Neither the Chairman nor Alasdair Oatts will be standing for re-election at this time which will leave 4 vacancies. The Chairman asked those present to think about the future of the Community Council and asked for members of the community to consider what they could contribute.

# 3. Matters Arising from previous meeting:

- a. Roads Issues: No update from Stewart Clarke. RA to email.
- b. Speed Limit in Kilmelford: Awaiting Police response.
- c. Bus Shelters in Kilmelford: Timetable to be updated at the same time as new shelter going in. Cllr McIntyre stated this should have been done by 05.04.08 and he will pursue this item.
  - d. Blaran Road end: No further information has been received.
- e. Kilninver Notice Board: This has been put up by NM with the assistance of Andrew Sandilands. Issue of insurance raised. RG awaiting a response from an insurance broker, he will pursue this.
- f. Problem weeds in Scammadale: No action from Council. At present residents of Scammadale attempting to control spread. Cllr McIntyre informed those present of a report by Strachur which relates to grants available. Cllr McIntyre to forward this to KKCC. Lengthy discussion re methods of managing and difficulties re safe use of chemicals and disposal of weeds. To carry forward and possibly bring up at Community Engagement Meeting.
- g. Sight lines at Arduaine: Owner of southern property has been issued official notice to remove fence and planting. Northern property has cut back some planting. It has been confirmed that the Council own to the bottom of the bank. John Stannard to advise on progress.

Issues not on Agenda:

No school issues raised with new attendees bringing numbers up sufficiently to maintain teaching staff levels.

The Chairman confirmed that the Fire Officer will attend October meeting

Draft Model Constitution to be discussed in Item 6 Future of the Community Council.

Glen Euchar House- The Chairman confirmed the planning consented to this dwelling included the temporary occupation of the garage building until the house erection is complete at which time the garage

building will de converted back to such. Planning Enforcement Officer is to ask for planning to stipulate changing of glass to garage doors

Logs on Degnish Road - RA has discussed with owner and confirmation given that they will all be removed or burnt by 05.11.08.

### 4. Land Around Kilmelford Hall:

There is an Area Committee Meeting tomorrow but this topic is not on the agenda as expected. Cllr McIntyre confirmed that the Local Plan is going in front of the Council for approval in September. The Council Reporter has recommended no change to the Local Plan. Views will then be discussed with the Councillors who can adapt all or some of the recommendations. It will probably be January/February2009 when the Local Plan is confirmed.

Cllr McDonald read out Written Submission stating that the Macleod's development is sufficient for the local population and no further developments are necessary at this time. Conclusion read to all present. One member of the public present objected to proceeding. Confirmation was sought from Georgina Dalton re rumours that the affordable housing was not to be built 1st as was a stipulation of planning consent. No information available to support or dispel rumour. RA to contact Lesley Chisholm, Enforcement Officer in order to ascertain the basis of the Affordable Housing Element and also to ascertain the method of management i.e. owned by ACHA and rented out or sold by Housing Association.

A letter from the Community Council is required within the next 2-3 weeks to restart the whole process. RG to write to Kenneth MacDonald and the 8 Local Councillors indicating the Community's intention to proceed with this application.

Margaret Cross raised the issue of visual impact should building be suspended. The Chairman confirmed once building has started there is little that can be done to expedite completion.
